What will this mean for residents

The new academic schedule for the majority of undergraduates is different in the following ways:

- The start of the academic year is earlier with Freshers' week commencing 18 September, meaning students will start to arrive from 11th September but most will arrive at the weekend 16/17 September 2023
- The Winter vacation and the Easter vacations are shorter. The Winter vacation runs over three weeks instead of four starting 18 December with students returning to their studies 8 January 2024. As the first three weeks back are classified as revision and assessment, you may see a phased return of students to campus.
- The Easter vacation is two weeks instead of four and the dates will move each year according to the dates for Easter. In 2024 the vacation starts on 25 March with students returning to campus for teaching 8 April 2024. So, you are likely to see arrivals happening over the weekend 6/7 April 2024.
- For the majority of undergraduate students, the end of the academic year happens sooner with their second semester ending on 7 June 2024. You may start to see students vacating campus throughout that week in the run up to the end of their academic year.
- Postgraduate students and students on other types of programmes running to different
 dates means there will still be students on campus over the summer period as before, as well as
 visiting students and conference guests.
