Cllr Ravilious had forwarded a message from Martin Lawn, CYC as follows:

"Sorry for the delay but Yorkshire Water do take their time in surveys as permits are required to work on the highway, after a survey last week (Manhole cover number SE62508101) with a camera down the sewer pipe this has dropped 40% at 10m point and allowing water to ground and is therefore causing dip in highway.

Raised work will commence for a 2.5m relay at 1.7 m deep in highway and will be reinstated after completion of work.

A permit will be raised on 14 Day dig on the highway due to its complexity and convenient start date then when it's completed Yorkshire Water will confirm to us that the job reference 27730406 is closed.

I hope this information is helpful now to to public complaint or complaints and resolves the situation and frustration of this carriageway dip".

23/96 To report and make relevant recommendations on new planning applications:

- 15/00166/FULM - Residential development of 156 dwellings with associated access, highways, and open space @ Land Lying To The South Of Hull Road Resolved / Objection (Unanimous)

This application must:

- a) Provide proportionate evidence in order to demonstrate that the traffic generated does not exceed the cumulative highway capacity of Field Lane and Main Street West within Heslington Conservation Area, factoring in any other allocations and/or any recent planning permissions within the local Area;
- b) Set out any mitigation measures in respect of congestion impacts, highway safety, vehicle/cycle/pedestrian separation and ease of access from and onto Field Lane/Main Street West.

This application should not harm the character, appearance and residential amenity of the Heslington Conservation Area, from the impacts of any significant increase in vehicular traffic on the stretch of Field Lane and Main Street West running through the Conservation Area (including road junctions within this stretch), over and above their highway capacity, as a result of through traffic that could be generated as a result of the development. Traffic surveys undertaken at sites on this stretch of road on behalf of the University of York, by AECOM consultants in 2019, already indicated a trend of general increases in vehicle traffic flows at the 6 sites surveyed, with increases at 5 of the 6 sites between 2018 and 2019, including an increase of 16.9% at the Heslington Hall access near the traffic roundabout. Cyclist flows also increased significantly at 5 of the 6 sites during this time. While 2022 surveys, by TPS Transport Consultants Ltd, at the same sites show reduced vehicle and cyclist flows at all but one, it is highly likely that this is down to the short term impact of the Covid 19 epidemic and that flows will again increase in 2023. York Draft Local Plan Policy SS8 (Land Adjacent to Hull Road) indicates that site access will be via Field Lane (clause ii) and that there is potential for increased traffic flows (clause vii) as a result. This would add to already anticipated organic growth. Both the AECOM and TPS reports are included in this plan's online evidence base.
